2	The Secretary General shall display election schedule on the notice board of APSSITA, website and submit a copy to the Regulator.	02.07.2024 Tuesday
3	The member firms desiring to change their representative shall intimate changes regarding name of representative to the Secretary General along with necessary proof.	Up to 04.07.2024 Thursday
4	The Secretary General will display the provisional list of all members eligible to vote along with their National Tax Registration Number, Sales Tax Registration if applicable, the name and national identity card number of their representative at Notice Board and website of the APSSITA.	Up to 08.07.2024 Monday
5	The members who have any objection to the entries/changes in the list of voters shall send their objections in writing to the Secretary General	Up to 15.07.2024 Monday
6	The Secretary General will intimate action on the objection or changes sent by members.	Up to 22.07.2024 Monday
7	Any member aggrieved by the decision of the Secretary General, taken in the preceding clause, may make a representation to the Election Commission.	Up to 25.07.2024 Thursday
8	The Commission will decide the representation.	Up to 27.07.2024 Saturday
9	Any person aggrieved by the decision of the Commission or where the Commission fails to decide the representation within the stipulated time mentioned in the preceding clause may appeal to the Regulator, and decision of the Regulator in this regard shall be final.	Up to 30.07.2024 Tuesday
10	Regulator will decide the appeal.	Up to 09.08.2024 Friday
11	The final list of voters shall be displayed at notice board and at website of the APSSITA and shall also be submitted to the Regulator	Up to 12.08.2024 Monday
12	Any person who is eligible to contest the Election for the vacant posts of the Member Executive Committee shall send his nomination papers duly proposed, seconded by a duly registered voter and signed by the candidate, to the Secretary General on the prescribed form in accordance with the Articles of Association or Rules of the APSSITA. 16	The Election Commission will decide the objections filed under the preceding clause.	Up to 21.08.2024 Wednesday
17	Any candidate, aggrieved by the decision of the Election Commission, taken under preceding clause, where the Commission fails to decide within the time stipulated in the preceding clause may file an appeal to the Regulator.	UP to 23.08.2024 Friday
18	The Regulator Trade Organizations shall decide the appeal preferred under the preceding clause. This clause ipso facto applies to the nominees of the women seats.	Up to 30.08.2024 Friday
19	The Secretary General will receive the withdrawal forms from the nominees completed by the nominees who want to withdraw from the Election.	Up to 02.09.2024 Monday
20	The Commission will issue final list of candidates.	Up to 02.09.2024 Monday
21	The polling at the Aftab Steel Market, G.T Road, Gujranwala Near registered office of the APSSITA for Corporate Members and Associate Members . a) Counting of votes shall take place immediately after the polling hours under the supervision of polling officer in the presence of polling agents of the candidates, if any, at the designated site. b) The Election Commission shall declare provisional results.	Up to 06.09.2024 Friday
22	Any person elected, as member of E.C shall send his nomination for election as an Office Bearer duly proposed and seconded by an elected E.C. member and signed by the candidate to the Election Commission.	Up to 09.09.2024 Monday
23	Scrutiny of the nomination papers for the election of Office Bearers by the Election Commission and display of final list of candidates	Up to 10.09.2024 Tuesday
24	Polling for the election of Office Bearers.	Up to 12.09.2024 Thursday
25	The announcement of election results shall be made in Annual General Meeting of the Association called for this purpose.	Up to 17.09.2024 Tuesday
